# 2022 brought togetherness again for a successful year at Heartland Family Service.

Someone once famously said, "We don't grow when things are easy; we grow when we face challenges." We have seen an incredible period of growth at **Heartland Family Service (HFS)**. The agency has also seen a lot of change since March of 2020 when the pandemic started. Despite many difficulties, we pushed through and continue to serve our community and deliver life-saving services to people who need it the most. There was much to celebrate in 2022.


With little notice, HFS completed a successful temporary move of the Iherapeutic School to our One Oak facility. Other moves that took place included relocating our Restoring HOPE early childhood/family wellbeing service to our Central Office and our Housing & Financial Stability service to Nazareth Hall on our new Benson Campus. We

also expanded our **Assertive Community Treatment** service to rural Iowa and opened an office in Harlan.

On two different occasions, HFS was called upon to help families displaced by city action to close uninhabitable housing, serving 19 families displaced after the closure of the Flora Apartments and then, more recently, serving 160 families displaced after the closure of the Legacy Crossing Apartment complex. We launched a new Crisis Stabilization Residential Service at our Bridges location, as well as a new community-based Crisis Stabilization **Service**, to provide short-term residential or community-based care for those 18 and older following a mental health crisis. We were awarded \$4 million over a fouryear period to develop and implement a Certified Community Behavioral Health Clinic in Nebraska, an effort that will leverage the experience we've gained over the last two years developing and implementing a Certified Community Behavioral Health Clinic in Iowa. Lastly, we launched an exciting collaboration with Omaha ForUS, a new LGBTQ+ community center, serving as a fiscal agent and employer of record.

Like employers everywhere, we also experienced significant challenges due to the Great Resignation, with many positions left open and unable to be filled, especially for clinical roles. As a result, we completed a comprehensive salary benchmarking process and ensured all employees received

significant salary increases while also adding greater flexibility to our benefits package. While these changes helped to turn the tide, the unfilled positions and decreased ability to bill for services against the grants and contracts we earned wreaked havoc on our operating budget as 2022 progressed. We would have ended the year with a significant deficit but were fortunate to be awarded a \$1,289,888 grant from the Public Health and Social Services Emergency Relief Fund, dollars made available by the Coronavirus Aid, Relief, and Economic Security (CARES) Act, to offset losses in our behavioral health services. We also had a very successful fundraising year, concluding 2021-22 with a total of **\$23,470,818**, or 127 percent of our \$18,472,000 goal. As part of that process, our Grants and Contracts Team submitted 165 proposals, of which 142 were reviewed and 68

None of our achievements would have been possible without collaboration and partnership. As one of our trauma-informed behaviors clearly defines, we are better together. Many of our accomplishments are initial steps and there is more to do. What 2023 holds is unknown, but we do have the capabilities to face the future by keeping our mission front and center and leaning on each other for support. When we harness our passion to serve our communities and gather our strengths with a singular purpose, magic happens. And we certainly couldn't do it without you and your support. Thank you!





### Heartland Family Service 2022 Program Budgets





# **Program Highlights**







#### **Certified Community Behavioral Health Clinic**

Our Nebraska Certified Community Behavioral Health Clinic (CCBHC) provides services in 5 Nebraska counties- Washington, Douglas, Sarpy, Cass and Dodge. The goal is to improve access, quality and outcomes for Nebraskans needing behavioral health services. The holistic and coordinated services CCBHCs provide must be family centered, recovery oriented, and trauma informed. We will serve people with serious mental illness and substance use conditions. Clients who are enrolled receive an assessment to learn their specific needs. Staff will assist clients by linking them to services both at Heartland Family Service (HFS) and in the community to help meet their needs. An exciting part of this grant is that HFS will open a drop-in peer center for those needing support. Services provided by HFS CBCHC Nebraska include mental health counseling, mental health crisis response team, substance use treatment, recovery support, peer support, psychiatric services, mental health for youth in detention, and mental health for youth in childcare centers.

#### **Assertive Community Treatment**

In June of 2022, **Heartland Family Service** expanded our **Assertive Community Treatment** (ACT) service to rural Iowa by opening an office in Harlan, Iowa.

It is often referred to as a "hospital without walls" and is an evidence based approach to comprehensive, community-based treatment for those with serious mental illness. The ACT model is a highly individualized service with a "can-do" approach to lessen debilitating symptoms and to enhance the quality of life. The goal is to provide services so those with serious mental illness can live successfully in the community.

#### **Housing Relocations**

Heartland Family Service is now servicing all nine counties of the SWIA MHDS Region. The Council Bluffs ACT team serves Pottawattamie County and the rural team is serving our other eight locations in southwest Iowa.

Heartland Family Service responded to a tenant displacement emergency at the Flora Apartments in January of 2022. The City of Omaha declared the complex unlivable. Housing inspectors determined there were several permit code violations. Many of the residents were placed in hotels or temporary housing until new permanent homes could be found. HFS partnered with the Together Omaha and assisted 19 families to find new housing.

In late December, the City of Omaha reached out to request our assistance in helping to re-house 160 households as they shuttered the Legacy Crossing Apartments due to multiple code violations. **HFS** connected with 229 adults and 143 children. Our primary focus was to ensure all tenants had a safe place to stay temporarily and to provide food assistance. **HFS Housing** teams organized movers, and storage units immediately for those impacted. Work then started to find permanent housing for all involved. HFS staff and volunteers responded to this crisis situation and worked tirelessly to make sure everyone impacted received needed services. A big thank you to all who moved boxes and furniture and provided other help to our neighbors in need.

#### **Front Porch Investments Grant**

In November, **Heartland Family Service** received a \$199,920 grant from **Front Porch Investments** to determine the programming and financial impact of creating a site-based permanent supportive housing apartment complex in Omaha. The funding will assist with the initial project

planning that includes design and consultation, project management, site selection, and capacity study. Through these efforts, the project will address the need for an increase in affordable housing as Heartland Family Service works with Metro West Housing Solutions to identify a property that HFS would acquire, renovate, and ultimately provide Permanent Supportive Housing services in the Omaha community.

**HFS** projects that we will provide 25 units of single occupancy housing for individuals under 60% of the Area Median Income (AMI). HFS intents to sustain affordability for the duration of the project, 15 years at a minimum, with the expectation of sustaining affordability so long as **HFS** owns the property.


This is part of \$11 million received by the City of Omaha through Front Porch Investments for affordable housing development,

#### **Advocacy**

In October, Heartland Family Service implemented a successful legislative advocacy event. The theme was "Creating Safety and Self-sufficiency for Families."The focus was on demonstrating how mental health, housing, and substance use is related. Turnout was even higher than in previous years, with 26 candidates and elected officials in attendance. Participants were from Iowa and Nebraska, including those serving at both the state and county level.





The goal of services in this program area is to provide immediate, as well as long term assistance to members of our community experiencing issues of domestic violence, sexual assault, homelessness, and financial crisis.

### SHARON CAN.





Sharon was struggling with homelessness, hopping from friends and family, to shelters, to anywhere she could lay her head. This desperation and longing for a safe space led to Sharon using substances to cope and engaging in prostitution to survive. It was then, that she found the Heartland Family Service Sanctuary House concealed emergency shelter.

Sharon had a tenuous beginning while staying at the **Heartland Family Service Sanctuary House**, violating the confidentiality rule of the shelter. She also had picked up a new addiction - problem gambling.

During the time that she was discharged from the program, Sharon was served by the advocacy component of the **Sanctuary House**, continuing to try engaging with her from a community standpoint.

Sharon's advocate and case managers worked with her on setting small, achievable goals. At first, she struggled with trusting the **Heartland Family Service** staff, but by being reliable and honest, they were able to slowly build up the relationship.

Upon Sharon's return to the **Sanctuary House**, she started to attend meetings on a more regular basis. She was selected for the **Sanctuary House Rapid Re-Housing** service and became very involved in the housing search process. At the same time, Sharon started working on her Social Security Application and began having a better relationship with her children.

After such a promising turn of events, Sharon was unfortunately attacked while she was out in the community, searching for her new home. She spent a week recuperating, but didn't let that stop her on this journey to a new start.

While beginning therapy for her gambling addiction in the **Heartland Family Service Problem Gambling Treatment** services, Sharon began apartment viewings and slowly sharing more about her traumatic past. Just after she had bounced back strongly from her set-back, Sharon was signing a lease and moving into her own, safe place!

Sharon has continued to work with **Heartland Family Service** advocacy staff to obtain furniture, learn new skills, and even have her children visit at the new apartment for a few days at a time. She now loves attending therapy and keeping her apartment her "safe" space. Sharon wants to continue to grow and hopes to be able to one day speak about her experiences and inspire others. With the courage to rise above her struggles, **now**, **Sharon Can**.

## SARA CAN.





Sara had suffered past trauma which began to display itself through verbal and physical aggression. This made it impossible for her to receive services through her home school district.

These barriers made it difficult for Sara to build peer relationships or participate in any activities outside of the home. To attempt to diminish these hurdles for Sara, her school district and family made the decision to enroll her at the **Heartland Family Service One Oak** school.

When Sara began her time at One Oak, she had been diagnosed with depression and attention deficit hyperactivity disorder. She was unable to sit in a classroom for prolonged periods of time without displaying aggression or withdrawing for hours at a time.

Sara began to work with a therapist and participated in the Heartland Family Service Mental Health Counseling, including group therapy, yoga, and play therapy. Through these treatments and groups, she was able to rebuild trust and started to believe in herself again. After slowly beginning to spend more time in the classroom, support coaches and special education teachers helped Sara develop skills to become successful in her educational journey. She even began to develop friendships, which increased her self-esteem and reduced her depression and aggressive behaviors. Once she saw the success of being able to build friendships and understand her emotions, Sara expressed the desire to return to her home school district. The transition plan was developed, introducing more time at her traditional school.

While at One Oak, Sara completed individual and group therapy as well as social skills groups. With time, energy, and support from staff, Sara was able to return to her home school district full-time and has built many peer relationships.

With the help of **Heartland Family Service** staff, who worked hand in hand with her, **now, Sara can.** 



The services in this program area span the entire lifespan. # ALEXANDRIA CAN.





Ever since she was a young girl, Alexandria always knew she wanted to be a mother. She was elated when she learned that she was pregnant, but she found there were struggles right from the beginning.

During her pregnancy, Alexandria suffered from preeclampsia, a pregnancy complication that can cause high blood pressure and damage the liver and kidneys. She was hospitalized for this condition, and worried that it would affect her pregnancy. After these health complications, Alexandria was elated when baby Arianna was born, happy and healthy. However, her happiness was short-lived, as the struggles continued when she brought baby Arianna home.

Two weeks after they arrived home, Arianna suffered a terrible leg injury and skull fracture while Alexandria was recovering from her traumatic birth experience. Arianna was hospitalized for a week, causing further trauma to Alexandria as she saw her baby suffering. Arianna's father was taking care of her when the child suffered these injuries. It was unknown how the injuries occurred, as Alexandria was not present to witness the incident. However, the baby was removed from her home for nine months, in the course of the juvenile court investigation.

During the time that Arianna was removed from her mother's care, she was placed in a foster home that also presented difficulties to the situation and ended up not being a healthy environment for the baby. This terrible situation and the loss of custody of her newborn baby, caused Alexandria to suffer from post-partum issues, anxiety, and depression.

While Alexandria was desperately battling the courts to regain custody of Arianna, she reached out to **Heartland Family Service** for help. Alexandria was connected with the **In-Home Services** of our **Restoring-HOPE** services.

**In-Home Services** are designed to reduce or eliminate neglect, abuse, or exploitation of children. The goal of these services is to keep children out of the foster care system by educating and enabling parents to be self-sufficient in raising their children.

While a client of **Heartland Family Service**, Alexandria participated in counseling as well as parenting classes. The case workers at **Heartland Family Service** assisted her with gaining visitations with Arianna, as well as transportation to these visits and other appointments. Alexandria was also assisted in finding safe and stable housing through our **Rapid Rehousing** services, as well as applying for benefits.

After those long months of separation, Alexandria credits the **Heartland**Family Service staff and services for helping to reunite her with her daughter.

Because she has the support that she needs as a parent, now Alexandria Can.

In 2008, Russ Beernink contacted **HFS**s

Problem Gambling Treatment services to get help with a 30-year addiction. While in college, he started betting on football and basketball games. That addiction grew and he started betting regularly on horse races. Russ says he oversaw the family's finances, so it was easy to hide his problem until online banking became the trend. At that point, his family learned of the extent of his gambling addiction.

A family member recommended **HFS**.

Russ called and soon met his counselor, now retired Harlan Vogel. Russ says he was relieved that he didn't have to hide his problem anymore.

Russ soon gave up gambling for good but continued **Problem** 

Gambling Treatment services for two more years.

"Harlan saved my life," says Russ. "He got me to see what was going on and how I could be so much more if I could kick the gambling habit. I am so grateful to him and **Heartland Family Service**. They were there for me."

Russ made a promise to himself that if the day came when he could give back to **HFS** he would. That happened in 2022 when Russ presented **HFS** a check for \$10,000. It was a priority that Harlan be there so Russ could again shake his hand and show his appreciation.

Russ wants people to know that help is out there.


